General Terms

By accessing the online platform of LabShare and using its services, you confirm that you are in agreement with and bound by the terms of service contained in the Terms & Conditions outlined below. These terms apply to the entire website and any email or other type of communication between you and LabShare.

Under no circumstances shall LabShare team be liable for any direct, indirect, special, incidental or consequential damages, including, but not limited to, loss of data or profit, arising out of the use, or the inability to use, the materials on this site, even if LabShare team or an authorized representative has been advised of the possibility of such damages. If your use of materials from this site results in the need for servicing, repair or correction of equipment or data, you assume any costs thereof.

LabShare will not be responsible for any outcome that may occur during the course of usage of our resources. We reserve the rights to change prices and revise the resources usage policy in any moment.

License

LabShare grants you a revocable, non-exclusive, non-transferable, limited license to use the services of its platform strictly in accordance with the Terms & Conditions.

These Terms & Conditions are a contract between you and LabShare (referred to in these Terms & Conditions as "LabShare", "us", "we" or "our"), the provider of the LabShare website and the services accessible from the LabShare website (which are collectively referred to in these Terms & Conditions as the "LabShare Service").

- -Company: when this policy mentions "Company," "we," "us," or "our," it refers to LabShare Ltd., (Hungary, 4024 Debrecen, Piac utca 45-47. 2nd floor 1.) that is responsible for your information under this Terms & Conditions.





- -Country: where LabShare or the owners/founders of LabShare are based, in this case is Hungary
- -Device: any internet connected device such as a phone, tablet, computer or any other device that can be used to visit LabShare and use the services.
- -Service: refers to the service provided by LabShare as described in the relative terms (if available) and on this platform.
- -Third-party service: refers to advertisers, contest sponsors, promotional and marketing partners, and others who provide our content or whose products or services we think may interest you.
- -Website: site, which can be accessed via this URL:
- -You: a person or entity that is registered with LabShare to use the Services.

Restrictions

You agree not to, and you will not permit others to:

- -License, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise commercially exploit the app or make the platform available to any third party.
- -Modify, make derivative works of, disassemble, decrypt, reverse compile or reverse engineer any part of the app.

Payment terms

LabShare is entitled to financial consideration after successful matchmakings. The test's provider is charged in such cases.

Test performers (Labs) can choose a subscription plan. The plans are Basic, Professional, and Enterprise. Upon registration, all users with Lab status get a Basic package by default. Later, it can be modified under the "My Company"->" Plans and prices section" of the platform.

Basic users are to pay a matchmaking fee after every successful matchmaking. Matchmaking is considered successful when the customer accepts the given quote. The base of the matchmaking fee is the test's price and the fee to be paid is 4-12% of the amount. The system always shows the exact percentage and the sum of the fee upon quotation so that the test provider can calculate accordingly. Further details about the calculation's method can be found in the Basic package's description. The matchmaking fee is to be charged 30 days after the matchmaking, and the due date of the invoice is 40 days. If the test is not happening for any reason, users have the chance to contact us until the invoice is issued and request a cancellation. LabShare reserves the right to ask for an explanation and the background of the cancellation request.

Professional users do not pay matchmaking fees but a fixed monthly or yearly price, upon their choice. The initial price is 200 EUR monthly or 2000 EUR yearly. These amounts are applied for





the first year and are re-evaluated afterward by LabShare based on the annual traffic of the professional user. If there is no change in the annual pricing, the subscription is renewed for another year automatically. LabShare informs the user about the upcoming year's offer via email and system notifications; then, the user has 30 days to accept it or to choose another plan.

Enterprise users communicate their demands, and LabShare creates a customized offer to their needs. Therefore, prices vary, and all payment terms are discussed between the Parties.

All mentioned prices are in EUR currency. All of them are net prices, except for users registering from Hungary. For them, additional VAT applies on top.

Any payment not paid before the due date will attract interest at an annual interest rate of 8%.

Return and Refund Policy

Thanks for shopping at LabShare. We appreciate the fact that you like to buy the stuff we build. We also want to make sure you have a rewarding experience while you're exploring, evaluating, and purchasing our products.
